- 5. The Election Agent shall be a valid voter for the Staff Representative election and his/her name shall be reflected in the voter list.
- 6. Withdrawal of nomination papers to be done by Candidate only.



- 7. Other rules & regulations for voting of staff representative election will as per the rule framed by the undersigned for Delegate Election of the Bank.
- 8. No Postal Ballot will be entertained for voting in staff representative election.
- 9. Counting of the vote will be done by the Returning officer and by his authorized persons only.
