

- 8. The Election Agent shall be a valid voter for the Directors' election and his/her name shall be reflected in the voter list for director election / list of elected delegates.

# REGULATIONS FOR B.O.D. ELECTION OF THE E & N.F RAILWAY CO-OPERATIVE BANK LTD, KOLKATA-700012

- 1. The nomination form should be submitted to Sri Bijoy Halder, Returning Officer, E & N F Railway Cooperative Bank Limited or any person authorized by him. The nomination papers received will be serially numbered and the date and hour at which the nomination paper is received will also be mentioned. The acknowledgement will be issued to all nomination paper received. The nomination papers received after the date and hour fixed will not be considered.
- 2. The Final voter list (List of Elected Delegates) is available at this Bank office including all camp offices and Branch offices on payment of Rs.50/-(Fifty) only. The said Final voter list / elected delegates' list is also available at Banks' Website at <a href="www.enfrcb.in">www.enfrcb.in</a>. Name reflected in Delegate/ Voter list are eligible for nomination. The proposer and seconders' name should present in Delegate/ Voter list.
- 3. Nomination should be proposed and seconded by bona fide voters belonging to the Final voter list / elected delegates' list.
- 4. The R.O shall have power to appoint, Polling Officer/ Officers to conduct the B.O.D. election. Polling Officer/ Officers so appointed shall have power to conduct election according.
- 5. In addition to the conditions laid down in the Nomination Form:
  - (i) The term of office of the elected members of the Board shall be <u>Five (5) years</u> from the date of election.
  - (ii) No delegate shall be eligible for being a member of the board if he/she
    - (a) Has been adjudged by a competent court to be insolvent or of unsound mind.
    - (b) Is concerned or participates in the profits of any contract with this Bank.
    - (c) Has been convicted for an offence involving moral turpitude.
    - (d) Holds any office or place of profit under the Bank.
    - (e) Has been member of the Bank for less than a period of one (1) years / 12 months. His interest in any business of kind carried on by the bank of which he/she is a member.
    - (f) Has taken loan from the bank and after receipt of a notice of default has defaulted in repayment of such loan.
    - (g) Is a person against whom any amount due under a decree or order is pending recovery under MSCS Acts.
    - (h) Has been convicted for any offence under MSCS Acts.





- (iii) No person shall be eligible to hold, at the same time, office of the Chairman or Vice Chairman or Director or Delegate of more than one Bank or Cooperative Society.
- (iv) No delegate shall be eligible for being member of the Board, if he/she is holding the post of Director in existing board as they disqualified to be director again as per Bye Law U/S 49(2) of the Bank.
- (v) No delegate shall be eligible for contesting for the post of Director of the Board, if he/she failed to accrue right of membership of the Bank as provided in Bye Law 11(1) (a) and 79(b) and MSCS Act 2002 U/S - 28 & 29.
- (vi) In reference to the notice issued by the Returning Officer vide Ref. No: CB/Notice/Director\_elect/Sept23/2022-23 dated 15/09/2023, As per Section 10(A) of BR Act 2020, persons having special knowledge or practical experience in respect of one or more of the following maters namely:
  - i. Accountancy,
  - ii. Agriculture and rural economy,
  - iii. Banking,
  - iv. Co-operation,
  - v. Economics,
  - vi. Finance,
  - vii. Law,
  - viii. Small-scale industry,

Any delegate intends to avail the reservation quota on the basis of qualification shall submit their relevant documents duly endorsed by the competent authority (not below the rank of Gazetted Officer) along with the nomination form.

#### 6. VOTING:

- a) Voting shall be by secret ballot.
- b) Ballot papers shall be signed by the Presiding Officer.
- c) Every voter who desires to exercise his vote shall enter the polling station with its Rly. Identity card and wining certificate as delegate. The Polling Officer shall identify the member with reference to the final list of voters eligible to vote in the said Polling Station.
- d) The rendering of the English version may be made in any one or more languages in the same Ballot paper if the R.O. considers necessary as the case may be.



- e) Voting by proxy is not allowed.
- f) Immediately before the commencement of the Poll the Presiding Officer shall show the Empty Ballot Box to the Candidate or his agent present at the time.
- g) A blind/ infirm/ illiterate voter may take help of a companion to cast his vote. The Presiding Officer shall keep record in this respect in the manner as prescribed, provided that no person shall be allowed as companion twice.
- h) Canvassing of election by any person at the place where election are to be conducted shall be prohibited.
- i) The voters should put an arrow cross mark seal on the blank space provided for the purpose in the ballot paper against the name of the candidate/ candidates of his choice.
- j) If a voter enters a Booth before the expiry of polling time, he shall be allowed to cast vote even if the time for polling expires after his entry.
- k) If at any stage of the polling the proceedings are interrupted or obstructed or if at such election is not possible to take poll for any sufficient cause, Presiding Officer shall have power to stop the polling after recording his reasons for such action.
